Golf Outing Terms and Conditions:

Breakfast Hill Golf Club recommends at least 72 players to consider an 18-hole shotgun start. A total of 90 layers guarantee an 18-hole shotgun start. Less than 72 players may start using a modified shotgun start (Modified shotgun: A shotgun start in which a portion of the 18-hole is occupied in order for the club to open the remainder of the facility for public play).

PAYMENT: In order to reserve the date and time indicated above, I understand and by my signature on this Contract, hereby agree to the following terms:

- This Golf Outing Contract must be signed and returned with a \$500.00 non-refundable DEPOSIT to formally secure the requested outing date. This deposit can be paid with cash, corporate check, personal check, or credit card. Please make checks payable to "Breakfast Hill Golf Club".
- The FINAL GUARANTEE for all golfers and diners, including all outing volunteers, will be due 10 (ten) days prior to the outing date. The guaranteed number is not subject to reduction. Groups arriving with fewer than the guaranteed number of golfers and diners will be charged for the final guaranteed number.
- The FINAL BALANCE must be paid in full 48 hours (2 days) after the outing date. This amount can be paid with cash, corporate check, personal check, or credit card. Please make checks payable to "Breakfast Hill Golf Club".

PLAYER COUNT AND LIST: A "player list" or a "pairing list" must be mailed/faxed/emailed to the golf professional no later than three days prior to your Golf Outing Date [FAX: 603-436-5001, EMAIL: golf@breakfasthill.com]. Since Breakfast Hill Golf Club does a significant amount of pre-tournament preparation, if these lists are not received by the specified date, a \$25.00 fee will be charged to the organization.

DRESS CODE: It is the tournament coordinator's responsibility to notify all golfers of adherence to the dress code at Breakfast Hill Golf Club.

- All participants must wear collared shirts and appropriate bottoms consisting of non-denim shorts or pants. Absolutely no jeans or tee shirts will be permitted. If a tournament player is not appropriately attired, he or she will not be allowed to play on the course, unless a change of attire is obtained.
- Breakfast Hill Golf Club is a "spike-less" facility and all players must wear appropriate soft spike golf shoes.

FOOD AND BEVERAGE: All food and beverage must be purchased from the Breakfast Hill Golf Club. A menu, along with a food and beverage application, is included within your Outing Package. Breakfast Hill Golf Club must approve outside catering services. No personal coolers or containers are allowed.

INCLEMENT WEATHER: Cancellation of the outing will be considered only if Breakfast Hill Golf Club officially closes the course to all play. The tournament will be rescheduled based on date availability.

SIGNAGE: Breakfast Hill Golf Club is responsible for placing and removing any signage utilized by the tournament. Signage must be claimed by each event and removed from the property at the conclusion of the event. After 72 hours, all signage left at Breakfast Hill is subject to be discarded.

CANCELLATION POLICY: Up to 14 days in advance to have your deposit returned minus nonrefundable expenses. Within 7 to 13 days will result in a loss of your deposit only. Any outings cancelled inside 7 days before the event will be charged in full. It is the sole discretion of Breakfast Hill Golf Club as to determine if weather is cause for cancellation on the day of the outing. If Breakfast Hill Golf Club determines that an outing must be cancelled you will have the option to schedule another day or receive a full refund of all fees paid to date minus nonrefundable expenses. Any outings cancelled due to weather while in progress will have the fee prorated.

INDEMNIFICATION: Client hereby jointly and severally agrees to indemnify, defend and hold Breakfast Hill Golf Club, LLC harmless from all claims, suits, actions at law, judgments, liabilities, losses and damages (including attorney's fees) arising from the use of Breakfast Hill Golf Club property, however caused, including without limitations, any injury or damages resulting from negligent, careless, improper or unlawful conduct.

CONDITIONS OF THE AGREEMENT: Performance of the agreement is contingent upon the ability of Breakfast Hill Golf Club management to complete the same, and is voidable in the event of labor dispute or strikes, accidents, government (Federal, State, or Municipal) requisitions, restrictions upon travel, transportation, food, beverages, or supplies, and or other causes, whether enumerated herein or not, beyond the control of Breakfast Hill Golf Club, preventing or interfering with the delivery of services required for the private function. In no event shall Breakfast Hill Golf Club be held liable for other damages. Outing terms and conditions agreed to:
